Camp JCPS is an after-school care program at Jasper County Primary School for all children Pre-K (4 year olds) - 2<sup>nd</sup> grade.

We offer Daily and Weekly contract services. Space is limited.

This is a fundraiser for Jasper County Primary School. You will not receive an end of year tax deduction notice.

All pick up will take place at the back of the school by bus loading at the sign on display. Camp JCPS only takes place when students are in school.

After-school Care services include daily: snacks, homework help during quiet time, playtime in GYM or playground area, and/or computer time.

There is a \$25.00 registration fee for new families.

- Rates: \$60.00 first child/ \$50.00 each additional child
- Time: after school as well as early release days until 6:00 PM
- When: Starting Wednesday, August 11<sup>th</sup>- Thursday, May 26<sup>th</sup>
- Payments: **Due by the Friday of each week**

- Rates: \$20.00 per child/ each day
- Time: after school until 6:00 PM
- When: Starting Wednesday, August 11<sup>th</sup>- Thursday, May 26<sup>th</sup>
- Payments: **Due on date of service**

**EXTRA FEES**

- \*There is a **\$30.00 returned check fee**. After one returned check, all payments must be made in cash. Post Dated checks are not accepted.
- \* **There is a late fee of \$10.00** each week for any account not paid in full by the Friday of the week of services.( If there is no school on Friday, payments are due on Thursday.)

\*If your child is not picked up by 6:00, you will pay a late pick up charge of **\$10.00 per child in addition to \$1.00 per minute per child** that he/she is late in being picked up.

## Additional Camp JCPS information:

### Jasper County Primary School Code of Conduct

Students will be expected to adhere to the school code of conduct. Any instances of hitting, bullying, stealing, not following directions, or other types of poor behavior will result in a “strike” which follows with a one-day suspension from Camp JCPS. A second strike follows with a two-day suspension from Camp JCPS. Three strikes will result in the student no longer being able to attend Camp JCPS. It is also understood that severe behavior instances will result in the end of camp services for that child.

Parents you will be notified on paper at the time of pick up if your child receives a strike so you are aware of the situation. We want to work together to make sure all students have a safe, fun, positive camp experience.

### Pick up Policy:

For security purposes, any person picking up your child must be on your list of approved people who can pick up your child as well as have proof of identity.

Children must be signed out each day when leaving camp as well as the time recorded.

### Medications:

Camp staff will perform administration of medications when parents give the medicine as well as a signed written directive indicating dose and time of administration. All prescription medicines must be in the pharmacy bottle with the child’s name and dosage on it.

Should a child become ill, the staff will attempt to make phone contact with parent(s) then emergency contact. For emergency situations requiring immediate medical attention, Jasper County Rescue will be contacted and transport will be made to the hospital when determined necessary by the Jasper County Rescue.
